#### To Unitholders

#### Overview of the Thai Stock Market March 1, 2023 - August 31, 2023

March 2023 to August 2023: In the first half of March, the market plummeted further from Feb as investors panicked when the Federal Deposit Insurance Corp (FDIC) ordered the shutdown of Silicon Valley Bank (SVB) due to liquidity problems and Credit Suisse stumbled over missteps and compliance failures in recent years that cost it billions and brought liquidity risk. However, the problems were resolved in a timely manner in the second half of March as the Fed and Swiss National bank provided lending and stronger banks acquired the troubled banks. The market was also boosted by a surge in DELTA to an all-time high. In April, the market fell sharply, mainly weighed down by a 36% MoM plunge in DELTA share price after it was placed on the market surveillance list and then reported a 1Q23 earnings miss due to lower-than-expected gross margin. In the first half of May, ahead of the general election, the market surged on speculation on stocks that are expected to benefit from the promises of the political parties, especially the minimum wage increase, which raised speculation on leasing companies. 1Q23 earnings announcements also had a large influence on individual stock prices. However, after the election, the market sank as it brought worries that the winner of the election, the Moving Forward Party, would enact policies that would erode big-cap earnings. The party also plans to levy a capital gains tax. The prolonged negotiations over the US debt ceiling also soured the market mood. In the first half of June, the market slowly recovered, backed by another all-time high of DELTA and return of foreign investors' net buy, however, the market plunged in the second half of the month as DELTA plummeted due to be placed on the market surveillance list again and investors were worried about political ambiguity as the Moving Forward Party and the Pheu Thai Party, the leaders of coalition government, have yet to agree on the position of the House speaker. In July, the market surged back, thanks to rise of energy sector. Oil business share prices rose in tandem with crude oil prices while refineries rose in tandem with wider gross refining market. Rise of electronic component manufacturers' share price was also the main market support, especially DELTA that rose after it reported 2Q23 earnings beat. In the first half of August, the market weakened, pressured by delays in the government formation as the Prime Minister election was postponed to the latter half of the month. Additionally, analysts from several brokerage firms reduced their profit forecasts for 2023, following a decline in the overall 2Q23 performance of listed companies both YoY and QoQ. In the latter half of the month, the index rebounded, buoyed by greater clarity in the government formation after Mr. Srettha Thavisin received approval from more than half of the MPs and Senators to assume the position of Prime Minister. Investors speculated on stocks benefiting from the economic stimulus measures of the Pheu Thai Party. The SET closed August at 1,565.94.

SET return between March 2023 to August 2023 was -3.48%. The largest negative returns were in AGRI at -27.37%, MEDIA at -20.16% and PETRO at -19.52%. The largest positive returns were in ETRON at +16.42%, BANK at +7.00% and HELTH +1.14%. Foreign investors were net sellers of 110 billion baht.
