To Unitholders

As a capital-protection fund, CPRMF2 invests not less than 80% of its capital in government debt securities with remaining time-to-maturity of 5 years; matching the next fund's redemption period. The rest of the capital is invested in equity market to enhance the returns for the unit-holders. As of June 2024, the fund allocated 91.17% of its total NAV to government debt securities (Government bond, Debt securities guaranteed by MOF, Treasury bills and Bank of Thailand bonds), 4.64% to bank deposits and 3.62% to equities.

Comparing with first half of 2023 accounting period, the first half of 2024 fund's investment in government debt securities reduced to 91.74% from 93.19%. At the same time, the fund increased its portion in bank deposits to 4.64% from 3.01%, but reduced its investment in equities to 3.62% from 3.80%.

As we have managed Capital Protected Retirement Mutual Fund 2 for a period of half year on June 30, 2024, we would like to inform the net value to unit holder, The fund has a net asset 36,130,451.06 Baht in asset value or its earning per unit is at 15.1766 Baht. (As of June 28, 2024)
