Message from the Company

To Unitholders

As a Capital Protected Retirement Mutual Fund 4, CPRMF4 invests not less than 80% of its capital in

government debt securities with remaining time-to-maturity of 5 years; matching the next fund's redemption period.

The rest of the capital is invested in equity market to enhance the returns for the unit-holders. As of June 2025,

the fund allocated 94.65% of its total NAV to government debt securities (Government bond, Debt securities

guaranteed by MOF, Treasury bills and Bank of Thailand bonds), 1.72% to bank deposits and 3.63% to equities.

Comparing with first half 2024 accounting period, the first half 2025 fund's investment in government

debt securities increased to 95.2% from 94.7%. At the same time, the fund reduced its portion of bank deposits

to 1.2% from 1.7%, but maintained its investment in equities at 3.63.

As we have managed Capital Protected Retirement Mutual Fund 4 for a period of half year on June 30, 2025,

we would like to inform the net value to unit holder, The fund has a net asset value 64,296,644.09 Baht in

asset value or its earning per unit is at 15.7021 Baht.

In this connection, we would like to express our sincere thanks to the trust of all Unitholders has been

extended to us for your investment Capital Protected Retirement Mutual Fund 4. Should you have any further
