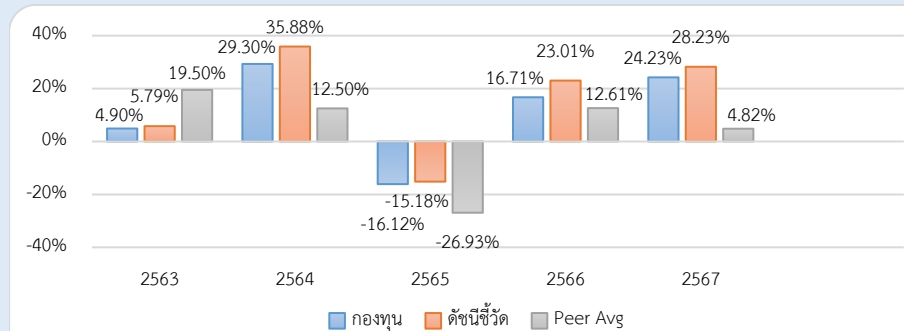

### นโยบายและกลยุทธ์การลงทุน

- ลงทุนในกองทุน Robeco Global Stars Equities IL USD จัดตั้งและบริหารจัดการโดย Robeco Institutional Asset Management B.V. กองทุนหลักมุ่งหวังสร้างผลตอบแทนที่ดีในระยะยาวและส่งเสริมการลงทุนด้าน ESG โดยมีการนำปัจจัยด้าน ESG เข้ามาพิจารณาใช้ในกระบวนการลงทุนนอกจากนี้ยังมุ่งหวังจะมีพหุพันธ์ด้านสิ่งแวดล้อมที่ดีกว่า Benchmark กลยุทธ์การลงทุน (ตามประกาศ SRI Fund) Screening / ESG Integration
- กองทุนหลักลงทุนอย่างน้อย 2 ใน 3 ของ NAV ในตราสารทุนของบริษัทต่างๆ ทั่วโลก ซึ่งดำเนินธุรกิจในประเทศที่พัฒนาแล้วเป็นหลัก โดยจะใช้หลักการวิเคราะห์ปัจจัยพื้นฐานในหุ้นที่มีกระแสเงินสดในระดับสูง มีอัตราผลตอบแทนต่อเงินลงทุนเพื่อการดำเนินงานของบริษัท Return on Invested Capital (ROIC) ที่มีแนวทางการพัฒนาอย่างยั่งยืนที่เหมาะสม
- กองทุนอาจพิจารณาลงทุนใน Derivatives เพื่อเพิ่มประสิทธิภาพการบริหารการลงทุน
- มุ่งหวังให้ผลประโยชน์การเคลื่อนไหวตามกองทุนหลัก โดยกองทุนหลักใช้กลยุทธ์การบริหารกองทุนเชิงรุก (active management)

### ดัชนีชี้วัด

### คำอธิบาย

**Maximum Drawdown :** เปอร์เซนต์ผลขาดทุนสูงสุดของกองทุนรวมในระยะเวลา 5 ปี ย้อนหลัง (หรือตั้งแต่จัดตั้งกองทุนกรณีที่ยังไม่ครบ 5 ปี) โดยวัดจากระดับ NAV ต่อหน่วยที่จุดสูงสุดไปจนถึงจุดต่ำสุดในช่วงที่ NAV ต่อหน่วยปรับตัวลดลง ค่า Maximum Drawdown เป็นข้อมูลที่จะช่วยให้ทราบถึงความเสี่ยงที่อาจจะขาดทุนจากการลงทุนในกองทุนรวม

**Recovering Period :** ระยะเวลาการฟื้นตัว เพื่อเป็นข้อมูลให้ผู้ลงทุนทราบถึงระยะเวลาดังแต่การขาดทุนสูงสุดจนถึงระยะเวลาที่ฟื้นกลับมาที่เงินทุนเริ่มต้นใช้ระยะเวลานานเท่าใด

**อัตราส่วนหมุนเวียนการลงทุน :** ความถี่ของการซื้อขายหลักทรัพย์ในพอร์ตกองทุนในช่วงเวลาใดช่วงเวลานึง

โดยคำนวณจากมูลค่าที่ต่ำกว่าระหว่างผลรวมของมูลค่าการซื้อหลักทรัพย์กับผลรวมของมูลค่าการขายหลักทรัพย์ของกองทุนรวมในรอบระยะเวลา 1 ปีหารด้วยมูลค่า NAV ของกองทุนรวมเฉลี่ยในรอบระยะเวลาเดียวกัน กองทุนรวมที่มีค่า portfolio turnover สูง บ่งชี้ถึงการซื้อขายหลักทรัพย์บ่อยครั้งของผู้จัดการกองทุนและทำให้ต้นทุนการซื้อขายหลักทรัพย์ที่สูงจึงต้องพิจารณาเปรียบเทียบกับผลการดำเนินงานของกองทุนรวมเพื่อประเมินความคุ้มค่าของการซื้อขายหลักทรัพย์ดังกล่าว

**Sharpe Ratio :** อัตราส่วนระหว่างผลตอบแทนส่วนเพิ่มของกองทุนรวมเปรียบเทียบกับความเสี่ยงจากการลงทุน

โดยคำนวณจากผลต่างระหว่างอัตราผลตอบแทนของกองทุนรวมกับอัตราผลตอบแทนที่ปราศจากความเสี่ยง (risk-free rate) เปรียบเทียบกับค่าเบี่ยงเบนมาตรฐาน (standard deviation) ของกองทุนรวม ค่า Sharpe Ratio สะท้อนถึงอัตราผลตอบแทนที่กองทุนรวมควรได้รับเพิ่มขึ้นเพื่อชดเชยกับความเสี่ยงที่กองทุนรวมรับมา โดยกองทุนรวมที่มีค่า Sharpe Ratio สูงกว่าจะเป็นกองทุนที่มีประสิทธิภาพในการบริหารจัดการลงทุนที่ดีกว่า เนื่องจากได้รับผลตอบแทนส่วนเพิ่มที่สูงกว่าภายใต้ระดับความเสี่ยงเดียวกัน

**Alpha :** ผลตอบแทนส่วนเกินของกองทุนรวมเมื่อเปรียบเทียบกับดัชนีชี้วัด (benchmark) โดยค่า Alpha ที่สูง หมายถึง กองทุนสามารถสร้างผลตอบแทนได้สูงกว่าดัชนีชี้วัดซึ่งเป็นผลจากประสิทธิภาพของผู้จัดการกองทุนในการคัดเลือกหรือหาจังหวะเข้าลงทุนในหลักทรัพย์ได้อย่างเหมาะสม

**Beta :** ระดับและทิศทางการเปลี่ยนแปลงของอัตราผลตอบแทนของหลักทรัพย์ในพอร์ตการลงทุน โดยเปรียบเทียบกับอัตราการเปลี่ยนแปลงของตลาด Beta น้อยกว่า 1 แสดงว่าหลักทรัพย์ในพอร์ตการลงทุนมีการเปลี่ยนแปลงของอัตราผลตอบแทนน้อยกว่าการเปลี่ยนแปลงของอัตราผลตอบแทนของกลุ่มหลักทรัพย์ของตลาด Beta มากกว่า 1 แสดงว่าหลักทรัพย์ในพอร์ตการลงทุนมีการเปลี่ยนแปลงของอัตราผลตอบแทนมากกว่าการเปลี่ยนแปลงของอัตราผลตอบแทนของกลุ่มหลักทรัพย์ของตลาด

**Tracking Error :** เพื่อให้พิจารณาความผันผวนของส่วนต่างของผลตอบแทนเฉลี่ยของกองทุนรวมและผลตอบแทนของดัชนีชี้วัด

ซึ่งสะท้อนให้เห็นถึงประสิทธิภาพในการเลียนแบบดัชนีชี้วัดของกองทุนรวมว่ามีการเบี่ยงเบนออกไปจากดัชนีชี้วัด มากน้อยเพียงใด เช่น หากกองทุนรวมมีค่า TE ต่ำ แสดงว่าอัตราผลตอบแทนของกองทุนมีการเบี่ยงเบนออกไปจากดัชนีชี้วัดในอัตราที่ต่ำ ดังนั้น กองทุนรวมนี้จึงมีประสิทธิภาพในการเลียนแบบดัชนีอ้างอิง ในขณะที่กองทุนรวมที่มีค่า TE สูง แสดงว่าอัตราผลตอบแทนของกองทุนมีการเบี่ยงเบนออกจากดัชนีชี้วัดในอัตราที่สูง ดังนั้น โอกาสที่ผลตอบแทนการลงทุนจะเป็นไปตามผลตอบแทนของ benchmark ก็จะลดน้อยลง เป็นต้น

**Yield to Maturity :** อัตราผลตอบแทนจากการลงทุนในตราสารหนี้โดยถือจนครบกำหนดอายุ

ซึ่งคำนวณจากดอกเบี้ยที่ได้รับในอนาคตตลอดอายุตราสารและเงินต้นที่จะได้รับคืนนำมาคิดลดเป็นมูลค่าปัจจุบัน โดยใช้วัดอัตราผลตอบแทนของกองทุนรวมตราสารหนี้คำนวณจากค่าเฉลี่ยถ่วงน้ำหนักของ Yield to Maturity ของตราสารหนี้แต่ละตัวที่กองทุนมีการลงทุน และเนื่องจาก Yield to Maturity มีหน่วยมาตรฐานเป็นเปอร์เซ็นต์ต่อปีจึงสามารถนำไปใช้เปรียบเทียบอัตราผลตอบแทนระหว่างกองทุนรวมตราสารหนี้ที่มีนโยบายถือครองตราสารหนี้จนครบกำหนดอายุและมีลักษณะการลงทุนที่ใกล้เคียงกันได้

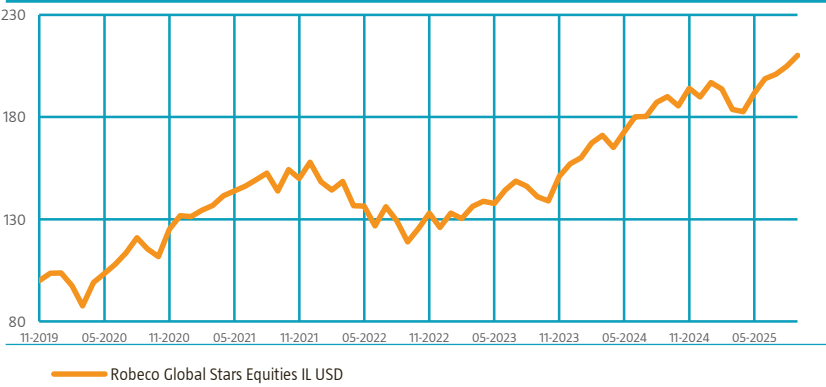

Performance

Based on transaction prices, the fund's return was 2.66%. In September, the portfolio had a positive absolute return, slightly lagging the benchmark. Sector-wise, our positioning in industrials and communication services helped performance most. The sectors technology and consumer discretionary, however, struggled most. In terms of stock selection, Alphabet again contributed most to performance. This was due to a very favorable remedy ruling regarding the Search anti-trust case, whereby the judge rejected harsh remedies proposed by the DoJ such as the forced divestiture of Google Chrome and barring payments for its search distribution. Moreover, Alphabet is increasingly confident AI can act as a tailwind for its Search business rather than a threat, visible in overall query growth and user growth in its AI Overviews and Gemini app. Taiwan Semiconductor (TSMC) also contributed strongly to results. Strong momentum in both AI ASICs and AI GPUs, with overall AI-driven demand, most notably the upcoming Rubin chip by NVIDIA, is causing a shortage in TSMC's wafer supply. Consequently, price hikes will be pushed through, helping margins expand from already high levels.

Market development

The 'Buy America' trade continues in full force, lifting overall global equity markets higher in September (+2.8% in EUR; +3.2% in USD). Despite the constant focus on trade protectionism, attacks on Fed independence and more domestic power politics, it has not knocked out US exceptionalism in the stock markets. In fact, the dual tailwinds of a lower dollar and lower rates in combination with the unstoppable AI capex train, have had a positive multiplier effect on US equities. The theme of AI remains so powerful that it even shows a degree of circularity, feeding between and off different sectors at the same time. Only time will tell whether this AI gold rush is mania or sensible deployment of capital, but the trade sentiment is very much in 'fear of missing out' (FOMO) mode. Meanwhile, emerging markets momentum continues to be strong as well, as trade tensions seem to have eased for now and China's 'anti-involution' campaign is being rewarded by investors too. Europe, however, has lost a bit of its 'vibe' given its lack of AI winners, fiscal budget issues resurfacing and a general lack of policy action follow-through.

Expectation of fund manager

Expectations for monetary easing seem to collide with entrenched inflation risks and political pressure points. At the time of writing, the US shutdown complicates the data gathering of, for example, jobs data, used as input for the Fed's future rate cut trajectory. Whether that impacts the timing of such cuts and how sentiment reacts to that, remains to be seen. Meanwhile, earnings season is around the corner, undoubtedly providing clues if the heightened optimism for some of the key themes, most notably AI, remains justified. Caution is growing, but sentiment seems stuck in a 'just keep dancing as long as the music is playing' mode. On the macro level, tariff impacts and its adverse global growth spillovers are likely to be pushed to the right, with its slow-burning stagflation effects resurfacing closer toward year-end. The reason why gold keeps making new highs seems at odds with the stock market rally, simultaneously reflecting both heightened market uncertainty and very narrow, thematically-driven, market leadership.

### Top 10 largest positions

Alpha is generated from active weights, hence we share the holdings whereby we deviate most from the benchmark below. Our top active position is Alphabet, as we believe that with its leading positions in Search, Cloud and the investments into its AI platform, Alphabet has a long runway for growth with attractive returns. Taiwan Semiconductor (TSMC) is our second-largest position and is the world's largest semiconductor manufacturer. TSMC is a key beneficiary from strong AI semi demand, as it enjoys a near-monopoly position in AI accelerators. Thanks to its strong process roadmap and leading packaging technology, TSMC has very strong growth prospects ahead. JPMorgan Chase completes our top three active positions, a high quality global bank with a strong capital base and loan loss reserve levels, and which has good leverage for a pickup in capital market revenues.

High inflation continues to impact the market. We are also concerned about slowing growth in the global economy and the rising risk of a global recession, which will impact the cyclical sectors most negatively.

In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

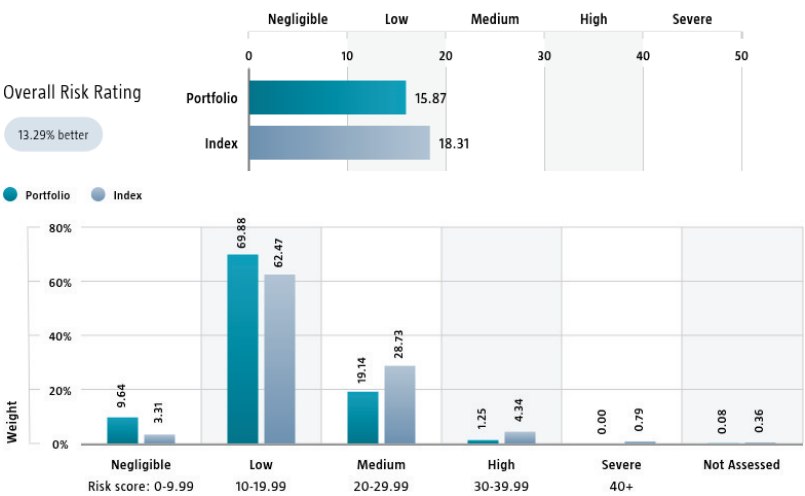

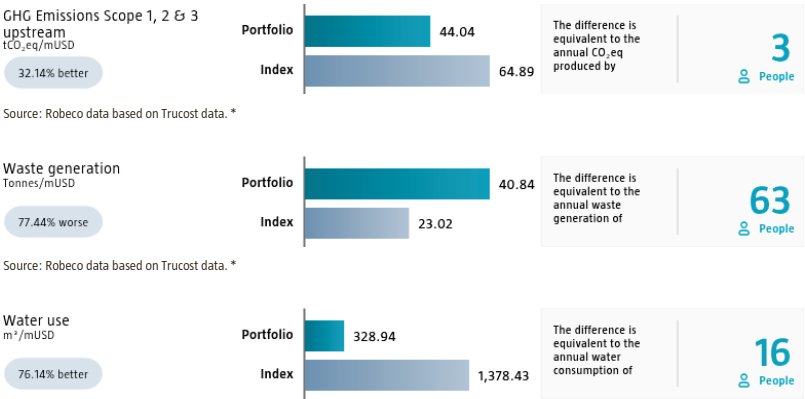

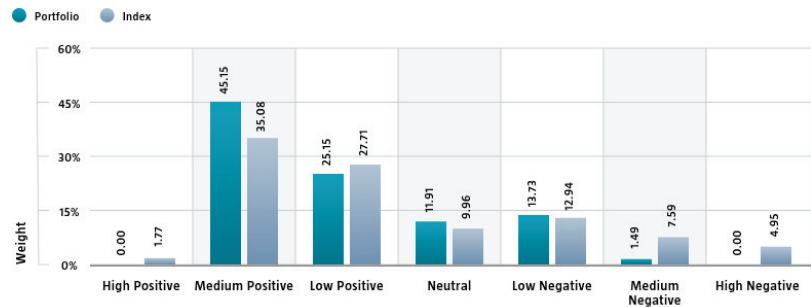

## Engagement

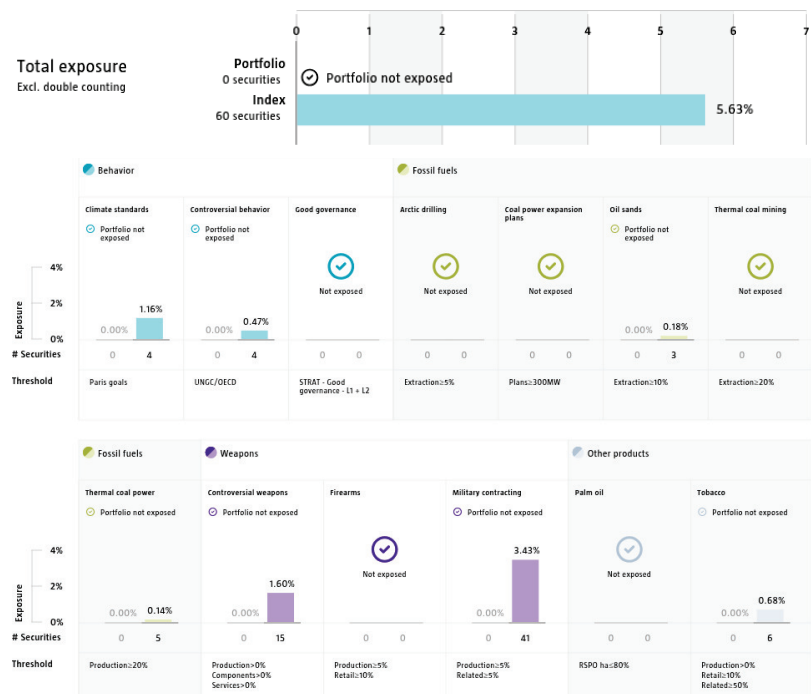

The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. ## Investment policy

Robeco Global Stars Equities is an actively managed sub-fund that invests in stocks in developed countries across the world. The selection of these stocks is based on fundamental analysis. The Sub-fund's objective is to achieve a better return than the index. The Sub-fund has a concentrated portfolio of stocks with the highest potential growth which are selected on the basis of high free cash flow, an attractive return on invested capital and a constructive sustainability profile. The Sub-fund aims at selecting stocks with relatively low environmental footprints compared to stocks with high environmental footprints.

The fund aims for a better sustainability profile compared to the Benchmark by promoting certain E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation and integrating ESG and sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, proxy voting and aims for an improved environmental footprint.

Michiel Plakman is Portfolio Manager and Co-Head of Robeco's Global Equity team. He is Lead Portfolio Manager Global Stars Equities and Portfolio Manager Global Engagement Equities.
